## 2025 Special Education Monitoring Timeline Noncompliance FAQs

## Which students were included in the Timeline Compliance Data section of our Annual Determination Letter?

To be included in the Timeline Compliance Data section of the Annual Determination Letter, students had to meet the following criteria:

- The student must have been enrolled on Census Day October 2, 2024, and STILL enrolled in the Local Education Agency (LEA) as of January 6, 2025.
- The student's most recent Special Education Meeting (MEET) record (Meeting Date or Pending As Of Date on or before 12/13/2024) for a specific meeting type (Initial Part B, Annual Plan Review, or Eligibility Reevaluation) in CALPADS had:
  - o Overdue Annual Plan Reviews or Triennial Reevaluations with
    - A Meeting Date or Pending as of Date that was more than 365 days prior to 12/13/2024 (for annual plan reviews); or
    - A Meeting Date or Pending as of Date that was more than 3 years prior to 12/13/2024 (for triennial eligibility reevaluations); or
    - A Pending as of Date that is less than 365 days prior to 12/13/2024 (for annual plan reviews) with a BLANK Meeting Delay Code or Meeting Delay Code of 90 – Late Without Cause; or
    - A Pending as of Date that is less than 3 years prior to 12/13/2024 (for annual plan reviews) with a BLANK Meeting Delay Code or Meeting Delay Code of 90 – Late Without Cause; or
  - Initial Part B Evaluations with
    - A Meeting Date or Pending as Of Date that was more than 60 days after the Parental Consent for Evaluation Date (for Initial Part B evaluations).

## When did the CDE pull the data from CALPADS?

The meeting data used for this section of the Annual Determination Letters was pulled from the CALPADS Operational Data Store on **December 13, 2024 (CALPADS Initial Certification Deadline)**. Any meeting data that was **posted to CALPADS** after that date is NOT reflected in the ADL.

Certified enrollment data were pulled on December 13, 2024, to confirm enrollment on Census Day, then a subsequent pull from the most current enrollment data was done on January 6, 2025, to confirm that the student was still enrolled in the same LEA.
